The Lecturer

Prof. Björn Christensen is Professor for Statistics and Mathematics at the University of Applied Science Kiel and has more than 15 years of experience as teacher, author and expert in Data Mining, Predictive Analytics, Big Data Analytics. Prof Björn Christensen published numerous scientific papers and publishes periodic columns such as "Angezählt" (Spiegel online) and „Achtung: Statistik - Alltagsthemen der Statistik zum Nachdenken und Schmunzeln“.

The Presentation

In the course of his lecture Prof. Björn Christensen will demonstrate that everyone can gain interesting and astonishing insight into the world of statistics even without previous knowledge.
